The Gandaki Province Government **has allocated funds** towards the cost of Korola Pokhara Triveni Marga Antargat Dedgaun Jhalbas Sadak(Doshro Khanda)(Ch 14+100-21+100)and intends to apply part of the funds to cover eligible payments under the Contract **for** IDO-NAW(BSE)-W-NCB-UG-01-2080/81. Bidding is open to all eligible as per Section V of bidding document.

2. **Infrastructure Development Office, Kawasoti, Nawalparasi (Bardaghat Susta East)** invites sealed bids or electronic bids from eligible bidders for the construction of Korola Pokhara Triveni Marga Antargat Dedgaun Jhalbas Sadak(Doshro Khanda)(Ch 14+100-21+100) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 221,380,000.00 (Without VAT)
- Minimum Work experience of similar size and nature:
 - a) Key Activities : Asphalt Concrete :- 750 cum per year within last ten fiscal years
 - b) One Road Project which value is at least NRs. 177,103,000.00 (Without VAT) within last 10 fiscal years

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Infrastructure Development Office, Kawasoti, Nawalparasi (Bardaghat Susta East)** at **2080-10-08 (22nd Jan, 2024) 13.00 Hrs.**
7. Electronic bids must be submitted to the office **Infrastructure Development Office, Kawasoti, Nawalparasi (Bardaghat Susta East)** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 PM on **2080-10-18 (1st Feb ,2024)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 Hrs on 2080-10-18 (1st Feb ,2024)** at the office of **Infrastructure Development Office, Kawasoti, Nawalparasi (Bardaghat Susta East)**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **83,40,000.00** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
